Question: 43

Topic: International Mobile Roaming Services

Senator Birmingham asked:

What action has the Minister asked ACMA or the ACCC to take in relation to the high costs of international roaming services? What actions, if any, have been taken to date?

Answer:

The Minister has asked the Department to work on this issue with the objective of lowering the high cost of international roaming services. This has resulted in the Department working with the ACCC and with ACMA.

The issue of international mobile roaming crosses jurisdictional boundaries both internationally and between Australian Government agencies. Consequently, the Minister has asked the Department to take the lead on this matter, in consultation with ACMA and the ACCC, where they have particular expertise and responsibilities.

The Department and ACCC have made submissions to the current House of Representatives Committee on Communications Inquiry into International Mobile Roaming Charges and further action may be prompted by the Inquiry.

The ACCC is currently consulting about proposed changes to the regulatory accounting framework record-keeping rules to cover international mobile roaming issues. ACMA provides information to consumers on international mobile roaming.

The Department early this year commissioned a consultancy report on the issue which has been publicly released and provided to the Inquiry. The Department also recently succeeded in placing the issue on the agenda of the APEC Telecommunications and Information Working Group.

The ACCC has indicated that international mobile roaming charges raise a problem of jurisdiction because they arise from services provided by different carriers in different countries. The Department is therefore continuing to press the issue in bilateral and multilateral contacts to encourage international cooperation on the matter.
