Below are the best estimates of expenses for the Department, the Australian Heritage Commission and National Parks, excluding the Natural Heritage Trust payment to the Department for the provision of services, eg staffing. Expense figures for the requested agencies from 1995-96 to 1998-99 were obtained from the relevant financial statements in the Annual Reports. Note that as a result of an enhancement to the Department's FMIS, the grants components of the Environment Program appropriation have been reported as an administered item for the first time in 1997-98.

Senator Bolkus asked:

"Can you come back to us with statistics on how many expressions of interests were lodged with you in respect of each one of the tenders?......In respect of finance and human resources, can you tell me how many expressions of interest there were, how many you have culled them down to and who they were once you made that decision?"

Answer:

As of 21 February 2001 there have been two approaches to the market for provision of elements of corporate services.

A request for Expressions of Interest (EOI) for provision of Human Resource and Financial Services was publicly advertised on 8 September 2000. Six responses were received. A shortlist of three respondents has recently been approved for progression to the Request for Tender stage (RFT). The shortlisted respondents are:

- PriceWaterhouseCoopers
- Accenture (formerly Andersen Consulting) and
- Deloitte Outsourcing Canberra.

A RFT for provision of Audit and Evaluation Services was released on 2 February 2001. Seven responses were received. These are currently under consideration.

No other EOIs or RFTs have been released to date. We expect the remainder to be released by the end of March 2001.

The Output Pricing Review Stage 1 is estimated to have cost the Department \$150,000 consisting of \$60,041 in consultant costs (KPMG Consulting) and \$90,000 as the estimated cost of Department officers' time.

The Output Pricing Review Stage Two is estimated to have cost the Department \$280,000 consisting of \$80,410 in consultant costs (KPMG Consulting) and \$200,000 as the estimated cost of the Department officers' time.

Senator Bolkus asked:

Who did the scoping work?
Can you provide for us the information as to who they were and what it cost?"

Answer:

A consultant from ASPECT COMPUTING (Mr Rodney Abbott) was engaged in late 1997 to assist the Bureau with a feasibility study to review the IT activities in the Bureau and to assess the potential for outsourcing in line with the Whole of Government Initiative for IT infrastructure. Consultancy cost was \$30,000.

A consultant from METAGROUP (Dr Wissam Raffoul) was engaged in October 2000 to assess the potential and cost of single points of failure and outsourcing risks for the Bureau's mission critical systems and to develop a template Service Level Agreement and Statement of Work consistent with OASITO guidelines. Consultancy cost was \$9,642.20

A consultant from Wyndarra Consulting (Mr Mike O'Loughlin) was engaged in December 2000 to assist the Bureau with a strategic risk assessment of the IT outsourcing project and strategies to minimise the identifiable risks. The consultancy when completed will cost \$14,400.
