# Re- 10am SBS Urdu Language Radio Broadcast dated 20th February 2005

Sunday 20th February was observed around the world as the 10th Day of Muharram (first month of the Muslim Calendar). On this day, Muslims observe the great martyrdom of Imam Husain, the grandson of Prophet Muhammad (s.a.w.). Imam Husain (a.s.) was brutally slain in Kerbala in Iraq with members of his family by the tyrannical and corrupt caliph Yazid son of Muwaiya some 13 hundred years ago.

Imam Husain (a.s) stood against an evil, corrupt, morally bankrupt ruler and stood for truth, fairness & justice.

A significant section of the Muslim community around the world observes this day with sadness and grief. This day is commemorated in a very somber mood by Muslims, and they refrain from any acts of entertainment on this day.

Complaint 1- Musical Songs played on SBS.

We were very disappointed to hear that music was played on this day during the program. In some countries such as Pakistan no music is played on TV or Radio stations. Historically SBS Urdu Radio has always observed this protocol.

# Complaint 2 --- Biased Speech

The speaker on the radio made a very scant reference to the Martyrdom of Imam Hussain (a.s.) and trivialized the whole event. He emphasized other events that took place on that date. The events he mentioned are not observed by Muslims and some of these events have been doctored in Islamic history to divert attention from the main events of Kerbala.

We would request SBS to allow speakers who are well versed in Islamic history & understand the importance of events that took place instead of those who give misinformation or create division in the society.

The members of this organization are very distressed at the lack of in-sensitivity and understanding shown by your program and request that you redress this by broadcasting an apology on the same Urdu program on Sunday 27th and put appropriate procedures in place to avoid this from repeating.

### Translation:

The listeners are aware that this month is the month of Moharram. Historically this month is of great importance. On the first of this month Caliph Umer Farooq was martyred. And this is the same month when Imam Hussein (grandson of Prophet Mohammad) was also martyred on the 10th of this month. It is also called the Day of Ashura. The day of Ashura is of great significance and importance and a lot of great events took place on this day. Prophet Adam was born on this day i.e. human beings were created on this day. He was sent to the earth from paradise on this day i.e. 10<sup>th</sup> of Moharram. His repentance was also accepted on the 10<sup>th</sup> of Moharram. Prophet Noah and his faithful people with him in the ship were saved by God after the ship wreck on the 10th of Moharram. Similarly Prophet Moses story of parting of the sea and crossing it with his people and getting saved by God whereas his enemies were drowned also happened on the 10th of Moharram. There are other important incidences that also happened on the 10th of Moharram. It is said that the Day of Judgement will also fall on the 10th of Moharram. So the Day of Ashura i.e. 10th of Moharram is of great importance. Where all these important incidences happened on the Day of Ashura the sad martyrdom of Imam Hussein also happened on this day. I want to make one thing clear that is usually done by people or in other words it is weakness in their faith. Some people take the 10th of moharram which is a great date as an unlucky date and they stop people from doing anything on this date saying the date is unlucky because Imam Hussein got martyred on this date. Please keep this in mind that people have to die or get martyred on some day. To say that because so n so has died on that day that day is unlucky is very wrong. In other sense, if some one dies on Friday and we start saying that Friday is unlucky, which is a day of great importance for Muslims and according to our belief anyone who dies on Friday all his sins are forgiven. So we might start taking an auspicious day as unlucky. Or if someone dies during the month of Fasting, according to our religion anyone who dies in the month of Ramadan will also be pardoned of all his sins. So we come to the conclusion that calling a day as unlucky just because someone has died on that day is wrong. Similarly the Prophet of Islam, Mohammad died on a Monday, if we start saying that Monday is an unlucky day because the Prophet died that day would be completely wrong. So the martyrdom of Imam Hussein that took place on the 10<sup>th</sup> of Moharram, which is a great date, and consider it unlucky is absolutely wrong. There is no doubt that martyrdom of Imam Hussein and the way he was brutally killed, is a sad incidence and we feel extremely sad and sorry for the incidence. There is a lot that can be learnt from his martyrdom and we should look at that aspect of it, but we should not look at it as something unlucky. In any case, the 10th of Moharram or Ashura is a great date. Prophet Mohammad noticed that the Jews used to fast on Ashura and he asked them why do you fast on this day, they replied because God saved Moses and his people on this date, so we celebrate the day and we keep a fast on this day. So the Prophet said we are very close to brother Moses we will also fast but be a little different to Jews. We will fast on the 9th and 11th of Moharram and not on the 10th like Jews. So the day of Ashura is a great day but the incidence of martyrdom of Imam Hussein has its own importance. We say that the Martyrdom of

Imam Hussein because it took place on this date i.e.  $10^{th}$  of Moharram, . it has increased its importance 10 times. Any person that dies on Friday, we say that person is so lucky he got Friday to die. Similarly when a person dies during Ramadan, we say he was lucky that he got to die in the sacred month of Ramadan. Similarly we say, Imam Hussein is very Lucky that he died on a very important date and God gave him Martyrdom on that important date of  $10^{th}$  of Moharram. We talk a lot about the Martyrdom of Imam Hussein, I just want to say one thing, and that is He didn't bow down in front of an evil force. That is the lesson that he has left for us. He has taught us by his great sacrifice that Right should always be upheld. No matter how cruel your enemy is, don't be afraid to say the truth and fight for the truth. So the best struggle is to say the Right and truth in front of the cruel King. Imam Hussein did that. May God give us the understanding to understand the importance of Imam Husseins Martyrdom and also to understand the reality of Ashura the  $10^{th}$  of Moharram.


