**QUESTION No.16**

**Senator Lundy** asked about:

Can you provide the following details for every tenant in each small business incubator:

- the tenants;
- the duration of their tenancies; and
- the rent they are paying?

**ANSWER**

Disclosure of details of tenancy arrangements and rental rates is restricted by provisions in the Small Business Incubator funding agreement. In addition, provision of this information would require the diversion of significant departmental resources.

Can you provide details of each of the small business incubators and their funding allocations, identifying if they were in increments, dating back to 2000?

**ANSWER**
