TERMS OF REFERENCE WORKING GROUP FOR THE AUTO INDUSTRY STRATEGIC GROUP

Having regard to the objectives for the Auto Industry Strategic Group identified by Minister Macfarlane on 12 August 2005, the Working Group will:

Identify opportunities and develop strategies which will help bring motor vehicle producers and automotive component producers together in order to find cooperative ways of enhancing Australian industry capabilities and competitiveness:

Identify opportunities and develop strategies to facilitate opportunities for the Australian automotive industry, and the supply chain in particular, to access global markets.

In doing so, the Working Group will:

- identify a role for state governments including areas such as clustering, networking and the development of management and other skills among the supply chain;
