- m. What amount has the Department spent in administering the program in each of the years of the programs operation?

## **ANSWER**

- a. The objective of the Item 69 concession is to increase the competitiveness of the space industry in Australia and ensure compliance with international obligations. It is intended to facilitate the transfer to Australia of sophisticated space-related technology and technical expertise. It is expected to be of significant benefit to companies proposing to establish and develop operations in the high technology, high value-added space sector in Australia.
