Senator EGGLESTON – What is the status of each election commitment within the portfolio? Which election commitments are experiencing slippages? Why? Where relevant, what are the revised implementation dates? What are the implications of this slippage?

ANSWER

The Department of Innovation, Industry, Science and Research has 21 election commitments. Of these 21 election commitments, 18 have been delivered, and three continue to be implemented.

The three commitments which continue to be implemented are:

	Title of Commitment	Status
1	Business Regulation – various measures (including Small Business Advisory Council (SBAC)).	In progress. Suitably qualified individuals were invited to submit an Expression of Interest for Ministerial appointment to the SBAC. The call for Expressions of Interest to the SBAC was backed by national advertising. Expressions of Interest closed on Friday 14 August 2009. Minister Emerson will shortly make offers to potential members and is expected to make an announcement of the composition of the SBAC when this is finalised. SBAC consideration of draft regulation impact statements will not occur until the SBAC is operational.
2	Education Revolution – Mission based compact funding agreements for universities	In progress - Program on track, no slippage. Mission-based compacts were announced in the 2009 budget as part of the reforms to the higher education sector. A discussion paper was released and consultations were held in mid-2009. Interim agreements, or transitional compacts, were negotiated with universities in late 2009 and are about to be published. Mission-based compacts will be negotiated with universities in 2010 to take effect from 2011.
3	Revitalising Australia's Public Research Sector	In progress - Program on track, no slippage. Development of 'hubs and spokes' is proceeding via Collaborative Research Networks program. A discussion paper inviting comment on the program was released in February 2010. Funding will commence in 2011. Statements of Expectation (SoEs), negotiated with each of the research agencies, were signed by Minister Carr 25 February 2010.
