QUESTION No.: AI-177

Is there any feedback yet from this year's higher education enrolment, whether universities are meeting participation targets for students from low SES backgrounds and other nominated under-represented groups?

What problems have been identified; and what is the government doing to address them? Are there any particular types of universities that have had trouble meeting those targets at this stage?

ANSWER

Tables 1 and 2 show the baseline, latest available enrolment data for 2010 and 2011 performance targets with respect to universities' low socio-economic (SES) and other underrepresented group targets. Assessment of whether universities have achieved their low SES and other underrepresented group 2012 performance targets will be based on final 2011 student enrolment data which is expected to be available in the December quarter 2012. Assessment of whether universities have achieved their low SES performance target is based on the interim low SES measure.

The introduction of the demand driven funding system will enable more students to have the opportunity to benefit from a university education including those students from low SES backgrounds and other underrepresented groups. Reward Funding of \$27.6 million in 2012 provides incentive for universities to lift the participation of students from low SES backgrounds and other underrepresented groups to ensure these students are not left behind with the introduction of the demand driven funding system. In 2012, the Higher Education Participation and Partnerships Program (HEPPP) will provide \$177.6 million to eligible universities to undertake activities and implement strategies that improve access to undergraduate courses for people from low SES backgrounds, as well as improving the retention and completion rates of those students.

In 2012, the Government is providing \$177.6 million through the Higher Education Participation and Partnerships Program (HEPPP) to assist universities to attract, support and retain students from a low SES status background.

The program consists of two components:

- A participation component to increase the participation of domestic undergraduate students from low SES backgrounds in higher education, and support the retention and success of those students. Under this component, universities receive funds based on their respective share of the indicator of domestic undergraduate students from low SES backgrounds.
- A partnership component to raise the aspirations and build the capacity of people from low SES backgrounds to participate in higher education. This will be done through outreach activities with stakeholders, including schools, State/Territory Governments, Vocational Education Training providers and community groups.

Universities reported in 2011 following the first year of HEPPP funding in 2010. Universities were asked to report on their activities, including details of the activity objectives, rationale of the objectives, progress towards objectives and the cost.

The reports did not indicate universities had identified problems in their chosen activities and strategies that would affect their ability to improve access to undergraduate courses for students from low SES backgrounds. Universities did not comment on problems associated with the retention or success of students from this cohort as a result of HEPPP activities.

The department is currently working on a more focused reporting framework for the 2012 year. The sector will be consulted as a part of this process. Further consultation with universities will also inform longer term evaluation activities for the program.
