### AUSTRALIAN RESEARCH COUNCIL (ARC)

# COMMONWEALTH SCIENTIFIC AND INDUSTRIAL RESEARCH ORGANISATION (CSIRO)

CSIRO's total cost of domestic and international travel for the period July 2011 to February 2012 is \$25,097,131. This includes fares and similar transport costs such as taxis and rental cars, and travel expenses such as accommodation and meals.

It is CSIRO policy that employees on official CSIRO business travel book their domestic and international airfares through CSIRO's contracted travel managements company, QBT. It is not mandatory for CSIRO employees to book travel expenses through QBT. Travel arrangements should be the most economical to CSIRO given the nature and purpose of the trip. The class of fare should be the lowest practical fare in economy class unless there is a business case or an entitlement to travel business class. Staff should only use flexible fares where there is a possibility that a scheduled meeting will not go ahead, or where there is uncertainty surrounding the time that meetings may conclude.

The effective management of travel is the responsibility of each unit within the Organisation and as such the detailed data is not readily available. The Organisation can obtain the information at this level of detail however it would involve a very significant application of the Organisation's resources which mitigate against providing the level of detail sought.
