Note: The overall number of students estimated to benefit each year from the extension of the concessional arrangements for independent ABSTUDY and Youth Allowance is based on numerous assumptions used in developing costings.

The breakdown of the estimated number of students by electorate requires the use of a postcode concordance (the percentage of a postcode that fits within an area) and is indicative only.

The column totals will vary from the sum of the component totals as a result of rounding caused by the use of a postcode concordance to derive the electorate distribution.

As the costings and electorate breakdown were based on actual student payment data, in order to protect individuals' privacy, populations <20 are reported as "<20".

Not all electorates contain Inner Regional areas and while these electorates will have zero beneficiaries, they have been reported as "<20".
