361. From 1 July 2011 to 31 January 2012 ASIC's Learning & Development Education Expenses \$443,466.11. YTD there has been a total of 2573 staff who have participated with an average cost per participant of \$172.35. For a breakdown of course type and participant numbers refer to the table below:

This is a total of 44 Graduate participants at total education costs from 1 July 2011 to 31 January 2012 of \$21,305 at an average cost of \$484 per graduate.

Study leave support is not applicable for in-house programs.

From 1 July 2011 to 31 January 2012 ASIC has provided study reimbursement for 170 staff at a cost of \$513,000, which is an average cost of \$3,018 per student. A total of 120 staff have access study leave with 516 study leave days was taken during this period, at an average of 4.3 days per person.
