QUESTION No.43 (Hansard 31/05/05, p.E15)

Senator Campbell asked about:

Parliament was advised on 29 March 2004 by Senator Minchin that the Commonwealth Government had turned down a request initially from SPP, and subsequently from it's receiver Ernst & Young (EY) and then Sandefer Capital Partners, to extend the effective excise exemption available to petroleum products from shale oil. Can you detail the reasons why the Commonwealth Government refused the request?

Can you also take on notice to provide us with copies of any documents relating to the request, including correspondence to and from the parties making the request and advice from other departments?

ANSWER

The Government indicated to SPP's Receivers and Managers that, in the context of Australia's overall energy policy and previous financial and other support provided to SPP, the Government had decided not to extend the exemption. Senator Minchin made a statement on behalf of the Government on 29 March 2004 which reiterated the Government's decision not to extend the exemption.
