13. In 2004/05 did the Agency contract any legal firms to provide services other than legal services (such as consulting, conduct of policy reviews etc)? If so, provide details including the name of the firm, the project involved and the cost of the contract.

Answer:

- 1. ASIC spent approximately \$8.828m on outsourced legal practitioners during the financial year 2004/2005.
- 2. The budgeted amount for outsourced legal practitioners in 2004/2005 was \$12.320m.
- 3. ASIC spent approximately \$31.297m on internal legal services in 2004/2005.
- 4. ASIC is a regulatory and enforcement agency. Administering and enforcing laws are our key functions. Accordingly, ASIC employs many in-house lawyers in all relevant areas of its operations.

As noted in answer 3, the cost of ASIC's internal legal services in 2004/2005 was approximately \$31.297m.

The budgeted amount for ASIC's internal legal services in 2004/2005 was \$31.3m.

The budgeted amount for ASIC's internal legal services in 2005/2006 is \$32.235m.

- 5. ASIC's total projected expenditure on legal services for 2005/2006 is \$44.869m.
- 6. The organisations or individuals contracted to provide legal services to ASIC in 2004/2005 (as shown in our financial records) include those listed in the table at Appendix A.
- 7. The total amount paid to each organisation or individual for the services referred to in answer 6 (as shown in our financial records) is listed in the table Appendix A.
- 8. In appropriate cases, ASIC may use an open tendering process or select tendering process (as described in the Commonwealth Procurement Guidelines) to procure legal services.

However, ASIC primarily relies on its in-house lawyers for the provision of its legal services. The vast bulk of ASIC's external legal service providers are barristers or solicitors who are engaged, on a one-off / as needed basis, for their personal or specialist legal expertise and advocacy skills in the context of current or anticipated litigation or disputes (and are therefore exempt from the Mandatory Procurement Procedures in the Commonwealth Procurement Guidelines).
