2. The department is actively engaged with the OECD across a range of science, technology and innovation (STI) policy areas, including enabling technologies and research infrastructure, and institutions. In 2010–11, the department was involved in 18 multilateral research projects on topics of direct interest to the portfolio's STI interests. Involvement in these projects included providing data, policy advice, feedback and expert representation to the OECD. New work was initiated on examining the exchange of various types of knowledge between parties, and on understanding the economic value of research and development and organisational know-how. The department continues to play a leading role in the OECD's work to develop new approaches and governance mechanisms for multilateral cooperation in STI to address global challenges.
