What was the cost of the Ministers' travel and expenses for the Community Cabinet meetings held since Budget Estimates?

How many Ministerial Staff and Departmental officers travelled with the Minister for these Cabinet meetings?

What was the total cost of this travel?

ANSWER

There have been five Community Cabinet meetings held since Budget Estimates Hearings of 2-3 June 2008. Minister Carr and accompanying staff have travelled to four of these meetings. Minister Carr did not attend the Community Cabinet meeting held at Yirrkala, Northern Territory on Wednesday, 23 July 2008.

The total cost of the Minister's travel and expenses for the four Community Cabinet Meetings since Budget Estimates is \$1836.81 (see Attachment A)

- For the Community Cabinet meeting held in Mackay, Queensland on 29 June 2008, two Ministerial staff travelled with the Minister to the meeting, and no Departmental or locally based staff attended this meeting.
- For the Community Cabinet meeting held in Hallett Cove, South Australia on 14 August 2008, two Ministerial staff travelled with the Minister to the meeting. Two locally based Departmental staff attended this meeting also the AusIndustry State Manager; and the Enterprise Connect State Manager.
- For the Newcastle, New South Wales Community Cabinet meeting held on 29 September 2008, two Ministerial staff travelled with the Minister to the meeting. Two Departmental staff attended this meeting the locally based Regional AusIndustry Manager, and the Assistant Regional manager who is also locally based.
- For the Launceston, Tasmania Community Cabinet Meeting held on 5 November 2008, two Ministerial staff travelled with the Minister to the meeting. Two Departmental staff attended this meeting the Secretary, and the locally based AusIndustry State Manager.

The total cost of travel for Ministerial Staff and Departmental Officers who have attended the four Community Cabinet Meetings since the Budget Estimates on 2 and 3 June 2008 is: **\$8197.47**(see **Attachment A**).
