Senator MASON: TAFE is not my area, as you should be aware, Senator Cameron.

Universities and research is my area. What is the current balance of the Education Investment

Fund?

Dr Hart: The current balance, as at 30 June 2012, was \$4.298 billion.

Senator MASON: What is the total interest earned so far by the fund and its predecessor?

Dr Hart: \$922 million from EIF and, from its predecessor HEEF, \$456 million.

Senator MASON: How much of the funds have been committed?

Dr Hart: In total, \$4.554 billion.

Senator MASON: How much has been spent?

Dr Hart: The sum of \$3.108 billion has been spent. So there is \$1.446 billion in future

commitments.

Senator MASON: Committed but not spent?

Dr Hart: That is correct.

Senator NASH: Can I ask you to take on notice exactly what the commitment is to and what

has been spent?

Dr Hart: Absolutely.
