Answer:

The Department

- 1. The Department has not changed its pay TV subscription since the 2012-13 Budget Estimates.
 - a) N/A.
 - b) \$2,800.

- 2. Yes, there have been changes to the Department's newspaper subscriptions since the 2012-13 Budget Estimates hearings.
 - a) The Department has increased the number of newspapers purchased. The Department now purchases more copies of The Canberra Times, The Sydney Morning Herald, The Australian and The Financial Review. The reason for the increase is due to the creation of the Australian Renewable Energy Agency (ARENA) support division and a number of restructures across the Department. The increase in newspapers will increase newspaper costs by approximately \$1,300 per annum.
 - b) \$7,360.63.
- 3. Yes, there have been changes to the Department's media subscriptions since the 2012-13 Budget Estimates hearings.
 - a) The Department decreased the number and type of magazines. The Department now purchases fewer copies of BRW and The Economist. The reason for the decrease is to reduce costs across the Department. The reduction in magazines will save the Department approximately \$1,000 per annum.
 - b) \$20,272.91 on professional subscriptions and \$2,662.82 on magazines.
- 4. 2011-12 financial year costs:
 - a) Pay TV: \$9,573.80.
 - b) Newspaper: \$37,860.46.
 - c) Magazine: \$138, 705.23.
- 5. The Department provides one subscription to the Minister's office. The subscription is for the Australian online. The cost for this financial year to date is \$47.20. The cost for the 2011-12 financial year was \$35.40.

ARENA

There has been no change to ARENA's media subscriptions since the 2012-13 Budget Estimates hearings. Questions relating to the 2011-12 financial year are not applicable because ARENA was established on 1 July 2012.

Geoscience Australia

- 1-2. There has been no change to Geoscience Australia's (GA's) pay TV, newspaper or magazine subscriptions since the 2012-13 Budget Estimates hearings. The cost this financial year to date:
 - Pay TV subscriptions: \$914.
 - Newspaper subscriptions: \$1,103.
- 3. Yes, there have been changes to GA's magazine subscriptions since the 2012-13 Budget Estimates hearings. One subscription was cancelled and eight were migrated from print only or print+online to online only. The costs not incurred totalled \$11,251. The cancelled journal was *Izvestiya: Physics of the Solid Earth*. The journals migrated to online access only were: *Economic Geology, Exploration Geophysics, IEEE Transactions on Geoscience and Remote Sensing, Nature, Nature Geoscience, Palynology, Science* and *Spatial Source*.
