Future travel is dependent on business requirements and business areas operating budgets. Travel by departmental officials is undertaken to meet business requirements while ensuring the effective, efficient, ethical and economical use of resources.

5. In line with Government policy, as at 1 November 2012 the Department introduced a domestic travel policy restricting the use of Business class travel by departmental officials, including SES Officers, on short haul flights between Canberra, Melbourne and Sydney. This policy has seen a reduction in Business class domestic fares.

Business Class is the approved class for overseas travel for departmental officials, unless a different class of overseas travel is a condition of the official's employment contract. However, Business class travel is not available for travel on the Canberra – Sydney and Canberra – Melbourne legs of overseas travel.

- 6. Lounge membership is provided annually to employees on the basis that it provides effective and efficient use of the traveller's time and is not based on classification level. As at 30 November 2013, 644 Qantas and 55 Virgin memberships are currently in use by departmental officials. These were purchased at a cost ranging from \$249 to \$900 depending on the length of the membership and pricing under Whole-of-Australian-Government travel arrangements.
