A major focus of the evaluation was on the operation of the research funding mechanisms; Research Training Scheme (RTS), Institutional Grants Scheme (IGS), and the Research Infrastructure Block Grants Scheme (RIBG). In examining these schemes, the evaluation assessed the validity of current research performance indicators, their weightings in the performance formulae, their effect on particular disciplines, universities and student groups, and the effectiveness and impact of the current transition arrangements.
