  - i) their cohort (eg in 2005, HECS liable students commencing in 2005)
  - ii) students able to be effected [for i) but excluding students in national priorities]

## Assumptions:

The estimated number of commencing students is the estimated commencing load at each provider multiplied by the student to load ratio for domestic commencing undergraduates in 2003 for each provider

Increases will only apply to commencing students in 2005 - estimated to be 37 per cent of EFTSL in 2005

Increases will only apply to students commencing 2005 onwards estimated to be 54 per cent of EFTSL in 2006

Increases will only apply to students commencing 2005 onwards estimated to be 74 per cent of EFTSL in 2007

Increases will only apply to students commencing 2005 onwards estimated to be 87 per cent of EFTSL in 2008

2003 actual EFTSU was used as the basis for calculations of EFTSL

Assumes providers will maintain the same percentage increase in student contributions for 2006, 2007 and 2008 as indicated in 2005
