### Question

#### **AUSTRALIAN YOUTH MENTORING NETWORK**

Minister Garrett recently stated in a speech to the Australian Youth Mentoring Conference in November 2011 that the Commonwealth had provided the Australian Youth Mentoring Network with \$600,000 over three years to continue its mentoring programmes. Which programme and funding has this \$600,000 come from? The funding given to the Australian Youth Mentoring Network was not publicised by the Government. In total, how many external organisations have been funded under the National Partnership, how much funding has gone to each, and what are the terms of each funding contract? What discretion does the Minister have to direct funding to organisations under the National Partnership? Would the Minister be able to announce new spending on organisations using the current pools of funding – or has the total spend already been allocated?

#### Answer

The Australian Youth Mentoring Network \$600,000 (2009-2012)is funded from the National Career Development element underthe Youth Attainment and Transitions National Partnership. This funding was approved by the then Minister for Youth the Hon Kate Ellis MP.

There are around 118organisations funded through the Commonwealth's contribution to the Youth Attainment and Transitions National Partnership. The Commonwealth's funding is being used to deliver the Youth Connections Program, School Business Community Partnership Brokers program and initiatives that requirenational implementation under the National Career Development element.

Under the Youth Connections contract, service providers are required to provide tailored case management and support to help young people to re-connect with education and training and build resilience, skills and attributes that promote positive choices and well being. The School BusinessCommunity Partnership Brokers improve community and business engagement with schools and registered training organisations to extend learning beyond the classroom, increase student engagement, deepen learning experiences, lift attainment and improve educational outcomes. The contracted

organisations are listed at Table 1 below.

The Commonwealth has responsibility for National Career Development and provides funding for a range of initiatives that require national implementation. The funded initiatives are listed in QONEW0853\_11.

Youth Connections and Partnership Broker programs are funded under Commonwealth Own Purpose Expense. All contracts for Youth Connections and Partnership Brokers were allocated under a competitive tender process. Funding is committed until expiration of the National Partnership.

As the funding is a Commonwealth Own Purpose Expense, the Minister has discretion to direct funding under the National Career Development component. In practice, funding for career development initiatives has been agreed through a National Career Development Working Group that includes representation from all jurisdictions, the Catholic Education sector and the Independent Education sector.

Future expenditure in the National Career Development element will be considered in the context of recommendations from the research project on the National Career Development Strategy – refer to QONEW0853 11.
