Executive Coaching and Leadership Training

- 3. The number of employees who have utilised these services, their employment classification and how much study leave each employee was granted
- 4. The names of all service providers engaged. For each service purchased from a provider listed under (4), please provide:
 - a) The name and nature of the service purchased
 - b) Whether the service is one-on-one or group based
 - c) The number of employees who received the service and their employment classification
 - d) The total number of hours involved for all employees
 - e) The total amount spent on the service
 - f) A description of the fees charged (i.e. per hour, complete package)

Where a service was provided at any location other than the department or agency's own premises, please provide:

- i. The location used
- ii. The number of employees who took part on each occasion

Answer

DEEWR has spent \$227,095.61 on executive coaching services and \$171,064.00 on leadership training services this financial year to date, as at 1 March 2012.

Details of the amount of study leave granted for each employee is provided in DEEWR's response to Question on Notice SQ12-000136, Education expenses.

Table 1 lists the staffing levels to whom executive coaching and leadership training services were promoted in DEEWR and Education, Employment and Workplace Relations (EEWR) portfolio agencies.

Table 2 provides a summary of expenditure for DEEWR and EEWR portfolio agencies. Figures include GST.
