#### Question

## Average cost for each student in school

Senator MASON: You may need to take this on notice but you will understand where I am heading, I am sure. How much does it cost taxpayers on average for each student in a public school—either on average or indeed maybe the average cost in each state and territory, in each jurisdiction? How much does it cost taxpayers to educate a student in a public school in each of the jurisdictions, in each state or territory? Ms Paul: The average cost of a student in a government school is measured. It is measured through the AGSRC, which is their current indexation mechanism. We can give that to you. We probably would have to take it on notice, but we can give it to you state by state for primary and secondary students. Senator MASON: Clearly this might be more difficult because the disparity is significant, but how much does it cost taxpayers for each student in independent or Catholic schools? Ms Paul: Sure. Senator MASON: Clearly they will vary enormously but if even the aggregate cost per jurisdiction—does that make sense?—could be provided to the committee that would be very useful. Ms Paul: Sure.

#### **Answer**

Australian, State and Territory government recurrent expenditure on school education is set out in the Report on Government Services (ROGS) published by the Productivity Commission.

The recurrent expenditure per full-time equivalent student (FTE) is published in the 2012 ROGS for government schools by primary and secondary schools. The latest available data is provided in Table 1.
