**Question**

**Visa subclass breakdown of independent school funding under the English as a Second Language – New Arrivals Program**

Provide a breakdown of the number of students receiving this funding in Independent schools by visa subclass (all visa subclasses both temporary and permanent humanitarian and non-humanitarian) in each state and territory in 2010-11, 2011-12 and 2012-13?

**Answer**

The English as a Second Language – New Arrivals (ESL-NA) Program funding is allocated for each eligible student claimed by non-government education authorities. Non-government education authorities submit claim forms that identify student enrolments against each eligible visa subclass. Claim forms are submitted in August (First Claim covering enrolments from 1 November to 30 June) and November (Second Claim covering enrolments from 1 July to 31 October) each year.
