Case Studies for Developing the National Trade Cadetship Initiative

Senator NASH: As and when you can, could you perhaps take on notice to inform the committee where those studies were done? I know you said a range and I appreciate you cannot give us the information now, but could you just take on notice, as and when you can, if you could provide that for us? Ms Houston: Yes.

Answer

In selecting Group Training Organisations (GTOs) to be the subject of case studies, attention has been paid to ensuring a mix of locations and a variety of industries. In some cases, the GTO is located in several states and conducts business across a large area.
