1. How much did each department/agency spend on taxis from Supplementary Budget Estimates in November 2013 to date? Provide a breakdown for each business group in each department/agency. 2. What are the reasons for taxi costs?

## **DEPARTMENT**

In the 2013-14 financial year, it is not possible to <u>fully</u> disaggregate expenditure between the Department of Education and the Department of Employment.

- For expenditure that can be identified as belonging to the Department of Education only, total expenditure on taxis from 1 December 2013 to 28 February 2014 was \$26,237.31.
- For expenditure that cannot be disaggregated, the combined expenditure on taxis by the corporate areas of both departments and the former DEEWR State Network from 1 December 2013 to 28 February 2014 was \$25,452.06.

A breakdown by business group is not readily available and would require an unreasonable diversion of resources to generate.

Taxis are utilised where they provide the most cost-effective transport option to deliver the outcomes of the department, including where staff are interstate on business.
