# **Project Management fees**

#### 1. Lifelong learning

An amount of \$60,500 was provided in 2001/02 for an Australian case study into lifelong learning development and best practice experiences. This project was a joint undertaking between ACTU, ACCI and ANTA with ACCI being the financially responsible partner. The outcome was the publication 'Lifelong learning and the world of work: CEET's surveys for ACCI, ACTU and ANTA'.

The project was successful because the research was published and distributed and conditions of the contract were met.

# **Industry forums**

ANTA has provided funding for ACCI to host 4 industry forums as follows:

# Travel
