Question:

Schools Funding announcement 11 March 2004-06-02 -Minister's media release: MIN 639/04

- 1. For the graphs on page 1 of the release:
 - a. Provide details of the source of the figures in both graphs
 - For each item: Commonwealth; State; Private government and nongovernment
 - b. Confirm that, on a per student basis, the figures indicate that non-government schools operate at 107% of the total resources in government schools?
 - c. Disaggregate these data as follows:
 - Catholic and Independent schools separately
 - Recurrent and capital funding:
 - For Catholic, independent, total non-government, and government
 - By source of funding: Commonwealth; State; private
 - o For 'private' sources: separate figures for fees; donations; other.
- 2. Page 2 of the release advised funding for Catholic systems. It states that funding for the current quadrennium was 56.2% of AGSRC (51.2% in the ACT).
 - a. At what % of AGSRC will Catholic systems be funded at in each State and Territory on average?
 - b. It also states that 'parents and friends' will contribute \$7.1 billion in fees and donations.
 - Please provide this information for each of the years 2005-2008
 - Explain how this figure relates to the \$4.1 billion in private fees in 2003/04 on page 1
 - c. Page 3 reports that 'parents and friends' will contribute a further \$12 billion in fees and donations
 - Please provide this information for each of the years 2005-2008
 - Explain how this figure relates to the \$4.1 billion in private fees in 2003/04 on page 1
- 3. Please provide disaggregated data for the table on page 3:
 - Indexation increases by the 3 sectors
 - 'policy' increases by the 3 sectors
 - enrolment changes in the 3 sectors
 - total increases by the 3 sectors

- 4. Re: 'funding maintained' schools as on page 3:
 - confirm that this 'funding maintained' status only applies until 2008
 - advise what will happen to the schools after that time.
- 5. Page 4 outlines funding for other programs.

Please provide figures on: (1) indexation; (2) enrolments (where applicable, e.g. ESL new arrivals) and (3) 'policy' or other increases, for each of the following programs – which should total the figures included in the release. Provide this information by the 3 sectors: government schools; Catholic systems; independent schools:

- 1.c State/Territory Budget Papers do not provide for a disaggregation to Catholic systemic and independent schools.

3. Disaggregated data

A detailed breakdown of quadrennium on quadrennium figures is extremely difficult as the policy, supplementation and enrolment changes during the first quadrennium will impact on the results. This results in the skewing of the data to reflect the changes in both quadrenniums rather than only the impact of the 2005-08 quadrennium.

To overcome this limitation, the figures supplied in this response are a comparison of 2008 to 2004. In effect, this provides details of how policy, supplementation and enrolment changes will impact on funding over the 2005-08 quadrennium.

It is important to note that the supplementation applies not only to the base 2004 funding, but also to the policy and enrolment changes. Supplementation for general recurrent funding is forecast to increase by 28.2% from 2004 to 2008. Below is a table with the breakdown of the supplementation drivers.

5. Funding for other Programmes

A detailed breakdown of quadrennium on quadrennium figures is extremely difficult as the policy, supplementation and enrolment changes during the first quadrennium will impact on the results. This results in the skewing of the data to reflect the changes in both quadrenniums rather than only the impact of the 2005-08 quadrennium.

The figures provided in this answer are based on the increase from 2004 to 2008. The answers do not exactly align with those provided in the media release as the effects of enrolment, supplementation and policy changes during the 2001-04 quadrennium are not included.
