Answer:

DEST Departmental Restructuring

Over the last year the Department of Education, Science and Training (DEST) had a number of changes to the organisation structure and these are detailed below. The 2004-2005 Outcome structure is the same as 2003-2004.

1 July 2003

- Questacon joined the Department.

21 July 2003

- The Indigenous and Transitions Group was formed. The Group was made up of two former Indigenous Group Branches and the Enterprise and Career Education Branch. The Enterprise and Career Education Branch is now called Transitions Branch.
- The following table lists the programmes that are now the responsibility of the Indigenous and Transitions Group.

- The new role of Indigenous Education Leader was created to report and represent the Department on matters dealing with Indigenous leadership.
- Corporate Strategy Group was restructured which involved a number of changes:
 - Parliamentary Section transferred in from Parliamentary, Assurance and Legal Group and merged with Communications to form the Parliamentary and Communications Branch.

- The corporate contracts role was transferred from Finance Branch to Parliamentary, Assurance and Legal Group. The Facilities role stayed within Corporate Strategy Group and the remainder of Finance Branch became a stand alone Branch reporting directly to the Deputy Secretary.
- Parliamentary, Assurance and Legal Group was renamed Procurement, Assurance and Legal Group.

6 October 2003

 A reorganisation of Information Services Group took place to strengthen the top-level structure given the changing complexity, the growth of DEST's IT systems and the in-sourcing of IT infrastructure functions from Department of Employment and Workplace Relations. A Group Manager position was created and the existing Branch and Section structure was reorganised.

12 January 2004

- Innovation and Research Systems Group was established with responsibility for progressing the Department's involvement in the research and innovation agenda. The Group comprises the Innovation and Research Branch from Higher Education Group and the Research Systems Branch which was formed from new sections and sections previously located in the Research, Analysis and Evaluation Group.
