- Supplementary recurrent assistance
- ESL Indigenous language speaking students
- Indigenous education projects
- Short-term special assistance
- "Mixed Mode" away from base
- ITAS in class tuition
- ITAS Year 10-12 tuition
- ITAS tertiary tuition
- Parent school partnerships
- Homework centres

Answer:

Indigenous Education Programme funding

Indigenous Education Programme (IEP) funding is appropriated under Section 14A of the *Indigenous Education (Targeted Assistance) Act 2000.* The IEP funding is limited to the amounts specified in the legislation. It is comprised of a number of programme elements: Supplementary Recurrent Assistance (SRA), Targeted Projects and Programme Support, and since 1 January 2005, Indigenous Education Direct Assistance (IEDA).

SRA is distributed to government and non-government education providers on a per capita basis and will fluctuate with enrolment growth. Enrolment changes may impact on the funding available for Targeted Projects.

Funding for "Mixed-mode" Away from Base is appropriated under Section 13 of the *Indigenous Education (Targeted Assistance) Act 2000* and is demand driven.

End of year actual expenditure is not yet available for the 2006-07 and 2007-08 financial years.

There was no expenditure of Short-term special assistance in 2005-06.

Indigenous Education expenditures are required to be maintained at reportable programme levels, and the Financial Management Information System is structured to report at that level.
