Senator Wong asked on 1 June 2006, EWRE Hansard page 93.

Refers to DEST Question No E990 06.

Question:

Update E990_06 to include new funding agreements signed.

E990_06: In respect of each Australian Technical College where a funding agreement has been signed:

- (1) Who are the members of the consortium chosen to operate the Australian Technical College?
- (2) What are the names of the government and/or non-government schools in the consortium which will have responsibility for delivering the relevant year 11 and 12 school curriculum?
- (3) What fees, if any, will be payable by students at the college to the schools identified in part (2).
 - (a) for 'general' purposes and
 - (b) for accredited training
- (4) What are the registered training organisations (RTOs) in the consortium which will have responsibility for delivering the relevant accredited training?
- (5) What fees, if any, will be payable by students at the college to the RTOs identified in part (4).
- (6) How many campuses/locations does the consortium propose to establish and where will they be located?
- (7) How many students does the college expect to enrol (a) in total and (b) at each location identified in part 6, (i) in 2006 and (ii) when operating at full capacity.
- (8) What programs does the college expect to offer (a) in 2006 and (b) when operating at full capacity?
- (9) When does the college expect to be operating at full capacity?
- (10) What is the total sum of funding made available under this contract for the current budget year and over the forward estimates?
- (11) For the Catholic and independent schools that have responsibility within the College, what will be the schools' SES scores and level of general recurrent funding (per capita and total). Please also estimate the level of state or territory recurrent funding.

Answer:

Australian Technical Colleges

For parts (1), (2), (3), (4), (6), (7), (8), (10) see each college summaries below.

- (1) Note: Not all Colleges will be run by a consortium, however, this term is used in all summaries for consistency.
- (5) No further fees have been identified in the Business Plans.
- (7)(ii) Note: Projected enrolments for 2009 have been provided in response to this question to reflect the period of the funding agreement. However, many Colleges have indicated that they will continue to increase enrolments for a number of years after 2009.
- (8) Note: Programmes offered 'at full capacity' are provided for 2009 to reflect the period of the funding agreement. Additional programmes may be added later.
- (9) North Brisbane will be fully operational by 2008 and the remaining colleges by 2009.
- (11) The information requested will not be available until a formal application for recurrent funding has been lodged by the respective Colleges. Following that, student address data may need to be obtained and only then can an SES score be calculated. State and Territory governments are responsible for determining levels of their own recurrent funding for schools. A figure is available for ATC Port Macquarie and this is provided in the summary.

Australian Technical College - Eastern Melbourne - opened 2006

Consortium members: Ringwood Secondary College on behalf of the Victorian Department of Education and Training, MEGT Australia Ltd, and St Joseph's College, Ferntree Gully.
