VTE Programmes and Funding

Skilling Australia's Workforce Act 2005

New Apprenticeship Workforce Skills Development

These initiatives include: Group Training Targeted Initiatives; Group Training in the Trades; the Institute for Trade Skills Excellence; Industry Training Strategies; Strategic Intervention (incorporating the National Skills Shortages Strategy); the COAG Skills Package; the Australian Surf Lifesaver Training Academy; and Tools for your Trade.
- b) Payments are made directly to those who are eligible to receive payments and include Apprentices, Trainees, employers, New Apprenticeship Centres, industry bodies, training providers, government agencies and community organisations.

New Apprenticeship Access Programme
