#### **Question:**

Senator Marshall asked at *Hansard* (30 May 2006) page 14:

<u>Young persons</u> – Further to QoN W788-06, can the OEA please update the data provided in the answer to take into account what has occurred since the previous Estimates round?

#### **Answer:**

- a) AWAs approved in the financial year so far (July 2005 May 2006):
  - AWAs approved for persons aged greater than or equal to 18 but under the age of 21 (i.e. < 21, but 18+ yoa): 13269
  - AWAs approved for persons aged greater than or equal to 15 but under the age of 18 (i.e. < 18, but 15+ yoa): 7779
  - AWAs approved for persons under the age of 15 (i.e. < 15): 598

It should also be noted that the AWA approval figures are not cumulative i.e. < 21 years of age does not include figures already disclosed for the <18 and <15 years of age categories.

b) AWAs approved for persons under the ages of 21, 18 and 15 per month, for the previous 6 months (end of May 2006).
