- Using sport to improve young Indigenous people's education and life prospects (\$19.6m over four years; \$3.4 million in 2006-07)

Indigenous Budget Measures

Expanding the Indigenous Tutorial Assistance Scheme to vocational education and training students (\$21.8m over four years; \$3.1m in 2006-07)

- 1. This element commenced in January 2007. At 10 July 2007 approximately \$1.6 million had been committed, and approximately \$0.8 million had been paid under Provider Administered arrangements.
- 2. The breakdown of departmental and administered funds allocation for VET Tuition is:

- 1. Year 9 tuition is a component of the Year 9, 10, 11 and 12 Tuition programme element. Expenditure of Year 9 tuition since January 2007 cannot readily be isolated from within the full programme expenditure.
