Senator Fisher asked on 4 June 2008, EEWR Hansard page 118.

Question

Child Care Tax Rebate

- a) Provide how the Child Care Tax Rebate increase will provide families with significantly more assistance claimed, by family type, income bands and full-time/part-time.
- b) What is the average out-of-pocket costs for families using long day care centres and after school care, by family type, income bands and full-time/part-time care?
- c) What was the average out-of-pocket cost for families before the Child Care Tax Rebate change, by family type, income bands and fulltime/part-time care?

Answer

Please refer to tables below in relation to 698 (a), (b) and (c) The full-time long day care fee used is \$257 per week per child which is an estimated average fee for Australia for 2008 based on historical average growth rates in fees according to various Australian Government Census of Child Care Services.

The fee used for 25 hours of long day care is \$138.78 per week per child. This was estimated based on the above parameters.

The after school care fee is based on \$13.30 per session (3 hours per day) and has been estimated based on historical average growth rates in fees according to various Australian Government Census of Child Care Services.

Annual rates for long day care are based on 52 weeks in the year. Annual rates for after school care are based on 40 weeks in the year.
