#### Question

#### Income Support Recipients aged 50 years and over

Senator FIFIELD—Also, for what you have taken on notice as well, could you also provide that information [number of people receiving benefits] for people who are over the age of 50—obviously not youth unemployment rates. Ms Paul—No, we are onto it. Senator FIFIELD—Unemployment rates in those same years that I asked for in both— Mr Griew—You mean all of those breakdowns, yes? Senator FIFIELD—That is right. Senator BILYK—Could you also provide that information for people who are studying.

Income Support Payments to unemployed people 50 years and over
