How is the funding allocated?

Funding for the project is dependent on the uptake of Indigenous traineeships by participants within government agencies. Funding is divided into two streams, one for the direct training for employers and participants, and the other is for employment placement and retention strategies such as developing workplace mentors and the delivery of this mentoring and workplace support.

How is it monitored/accounted for?

The training components of the project are paid on the submission of evidence as to the delivery of the training and participant attendance and a tax invoice.

The employment components are paid on milestones including employment commencement, 26 and 52 weeks employment outcomes and Certificate IV completion. Evidence to support these milestones and a tax invoice are required for the payment.

How is this funding spent – what per cent goes to administration and to the project itself?

Training funds are paid on the delivery of specific training and no administration fees are payable.

The employment placement fees and implementation of retention strategies are paid on employment milestones and the progression in the accreditation of a Cert IV in Government Administration. Approximately 90 per cent of the employment placement fees are to be expended on retention strategies and the remaining is payable for administrative purposes.
