Question

ABCC - Any proceedings against Australian Workers Union

Senator ABETZ: I fully agree, and that is why I am writing myself an aidememoire—for exactly that purpose. Is the ABCC commencing any proceedings against the Australian Workers Union about contraventions that occurred between 2005 and 2007? Mr Johns: We will take it on notice. Senator ABETZ: Can I also ask you to provide whether in the past the ABCC has commenced proceedings against the Australian Workers Union, and the outcome of those proceedings, in the period 2005-2007. Mr Johns: Yes. Senator ABETZ: And how many proceedings have been commenced against the Australian Workers Union since 2007? Could you take all that on notice? Mr Johns: I am happy to take that on notice.

Answer

Fair Work Building & Construction has provided the following response.

Contraventions of the *Building and Construction Industry Improvement Act 2005* between 2005 and 2007 can no longer be the subject of civil litigation proceedings, as the two-year limitation period for any such proceedings has expired.

The ABCC commenced two proceedings against the AWU in the period 2005-2007 and four after 2007.
