#### Question

### **FWA - conciliation services**

Please advise by name the person conducting the conciliations, since 1 January 2010 as to: a. How many conciliations have been conducted? b. How many conciliations have not resulted in proceeding to the tribunal? c. How many conciliations have resulted in the case being settled? d. The number of: i. Unfair dismissal cases; ii. Adverse action cases; iii. Other matters.

### Answer

Fair Work Australia has provided the following response.

Members of Fair Work Australia can deal with a dispute in a number of ways, including by conciliation (section 595(2)(a) of the *Fair Work Act 2009* ('the FW Act')). The method by which members deal with matters is not separately recorded in the Case Management System and therefore cannot be extracted.

Conciliations for applications for unfair dismissal remedy (section 394 of the FW Act) are initially conducted by Fair Work Australia staff members. Fair Work Australia has 26 full time equivalent conciliators as at 31 May 2012.

Legal advice obtained by FWA suggests that the Minister, and not the General Manager, could claim public interest immunity from providing the names of persons conducting unfair dismissal conciliations in the first instance.

The public interest grounds for not providing the name of the person conducting conciliations are twofold; first, revealing the names of individual conciliators and their settlement rates gives the parties opportunity to 'forum shop' for a particular conciliator and; second, revealing the names of individual conciliators and their outcome data effectively involves an unreasonable and unwarranted disclosure of personal information about APS employees.

The list below includes conciliations conducted by staff members no longer employed by Fair Work Australia and conciliations conducted by Fair Work Australia staff members whose primary function is not conciliation.

It is not possible to accurately report on conciliations of applications for unfair dismissal remedy between 1 January 2010 and 1 July 2010 as the results framework which would allow reporting on this data was not in place until 1 July 2010.
