REPORT TO THE SENATE

1.1 The Employment, Workplace Relations and Education Legislation Committee presents its report to the Senate.

INTRODUCTION

1.2 On 12 December 2002 the Senate referred to the committee the particulars of proposed additional expenditure for 2002-2003 in relation to the Employment and Workplace Relations and the Education, Science and Training portfolios.

1.3 Senator the Hon Richard Alston was the Minister representing the Minister for Employment and Workplace Relations. The committee heard evidence from Senator Alston, the department and related agencies on the proposed estimates for the Employment and Workplace Relations portfolio. The following agencies appeared before the committee: Equal Opportunity for Women in the Workplace Agency; Comcare; the National Occupational Health and Safety Commission and the Office of the Employment Advocate.

1.4 The committee also heard evidence from Senator the Hon Richard Alston, as the Minister representing the Minister for Education, Science and Training. Additionally, it heard from officers of the department and related agencies on the proposed additional estimates for the Education, Science and Training portfolio including the Commonwealth Scientific and Industrial Research Organisation; Australian Research Council; and the Enterprise and Career Education.

1.5 The committee took into account the Portfolio Additional Estimates Statements 2002-2003 provided by the departments and also their Annual Reports for 2001-2002. Review of the proposed additional expenditure for the portfolio was carried out over three days.
