Outcome: 1 Output Group: 1.1 – Funding for schools

DEST Question No. E424_04

Senator Carr asked on 6 November 2003

Refers to DEST Question No E265_04

Question:

The Department has failed to answer the specific questions in its response to E265_04.

My question was specifically about the assumptions underlying the Budget estimates, for each of the years in the forward estimates, including:

- Enrolment projections; government and non-government; primary and secondary; retention
- Assumed transfers from non-government to non-government schools
- Assumed staffing levels and student/teacher ratios
- Indexation assumptions for each of the years in the forward estimates.

For example: the line item for government schools in Table 7 of Budget Paper No 1 shows an increase in Commonwealth funding from \$2,262m in 2003-04 to \$2,647m in 2006-07. The annual rate of increase is around 5% per annum.

- (a) How much of this increase is the effects of:
 - indexation assumptions;
 - demographics;
 - enrolment transfers;
 - retention assumptions;
 - other?
- (b) The same table shows an increase in funding of non-government schools from \$4,373m in 2003-04 to \$5,425m in 2005-06 How much of this increase was:
 - indexation:
 - enrolment growth;
 - transfers from government schools;
 - retentions;
 - other?

Given the delay in responding, can this information be provided by the end of November 2003?

2003-04 Budget Paper No. 1 Table 7

(a) - (b) The summary of expenses outlined in Table 7 of the 2003-04 Budget Paper No. 1 relates to the Education Function of the Australia Government. This table has been derived by the Department of Finance and Administration (DoFA) and consists of administered and departmental expenses from a number of portfolios, including DEST. Any further questions

regarding the formulation of this table, especially in relation to funding to portfolios other than DEST, should be directed to DoFA.

Information relating to DEST administered expenses contributing to the figures contained in Table 7 were provided to the committee in the answer to previous question on notice E265-04.

Enrolment projections are based on grade progression ratios, and make no assumptions about changes to retention rates. Further information on enrolment projections can be found at previous question on notice E287_02. Transfers from government to non-government schools do not form part of the methodology. Enrolment projections as at 2003-04 Budget are at <u>Attachment A</u>.

Staffing levels and student/teacher ratios are not relevant to the formulation of the forward estimates. Programmes are either per capita driven by student/beneficiary enrolment numbers (GR, ESL-NA, SAISO per capita, ABSTUDY and AIC) or capped funding amounts (SAISO, Country Areas Programme, Non-Government Centre Support, Capital, IESIP, Primary School Libraries and all Annual Appropriations).

Indexation in the estimates is based on indices agreed with the Department of Finance and Administration for each programme. A list of the indices applied to each programme is provided at <u>Attachment B</u>. Forward estimates for these indices cannot be publicly released.

The estimated accrual change from 2002-03 to 2003-04 for schools programmes managed by DEST is provided at <u>Attachment C</u>. The government sector figures contained in the table at Attachment C were previously provided in E266_04.

The year-on-year changes provided in the table at Attachment C are indicative of the year-onyear changes in the forward estimates, with the exception of the SES phase-in. SES funding arrangements will be fully implemented in 2004.
