Indigenous Education Strategic Initiatives Programme (IESIP)

A number of elements under the IESIP programme have entitlements calculated on a per capita basis. Under IESIP the principal elements funded on this basis and the numbers of students assisted are:

National Indigenous English Literacy and Numeracy Strategy

The National Indigenous English Literacy and Numeracy Strategy (NIELNS) is an element of the Indigenous Education Strategic Initiatives Programme (IESIP). Each initiative is a separate education project with its own targets and performance criteria. As such NIELNS initiatives may or may not impact all students enrolled with recipient providers. Separate data are not maintained on students who are directly or indirectly assisted under NIELNS.

# Indigenous Education Direct Assistance

The Indigenous Education Direct Assistance (IEDA) programme has a number of entitlements calculated on a per capita basis and the principal element funded on the basis of student numbers is the Aboriginal Tutorial Assistance Scheme (ATAS). Data collected under this programme indicates:

•	Numbers of students approved for ATAS individual and small group tuition	9,219
•	Numbers of institutions involved in providing ATAS tuition during school hours	$735^{2}$
•	Numbers of ATAS homework centres	583

## Bulked funded ATAS

A number of education providers across the school (for boarding schools), VET and Higher Education sectors are bulk funded to provide ATAS assistance to their students.

Numbers of students by sector covered under ATAS bulk funding agreements:

 Schools 1,301 1,153 VET Institutions 5,739 Higher Education Institutions

Vocational and Education Guidance for Aboriginals Scheme (VEGAS) and Aboriginal Student Support and Parent Awareness Committees (ASSPA)

513 VEGAS projects and 3,811 ASSPA committees were funded under IEDA in 2002. The ASSPA committees were associated with schools and pre-schools which had over 111,000 Indigenous student enrolments.
