Completion rates

As a large proportion of New Apprenticeships are traditional trades apprenticeships with a three or four year duration, it is not as yet possible to calculate a valid completion rate for New Apprentices who commenced under the current contract (1 July 2003 to 30 June 2006).

Quality assurance and monitoring

The provision of quality assurance and monitoring throughout the term of the New Apprentice Support Services contract (1/7/03-30/6/06) is conducted by the Department. The Department has developed the Performance Management Framework which details how the five Key Performance Indicators (KPI), comprising a total of 23 measures, are to be monitored, assessed and reported on a bi-annual basis.

The KPIs are:

- 1. New Apprenticeships Support Services and the New Apprenticeships Incentives Programme are administered in an accurate and timely manner.
- 2. Eighty percent employer and New Apprentice satisfaction level with the provision of New Apprenticeships Support Services.
- 3. Increase in the retention rate of New Apprenticeships at the six-month point of the New Apprenticeship and increase in the completion rates of New Apprenticeships.
- 4. Improvement in the number of Indigenous Australians and people with a disability undertaking New Apprenticeships. Commencements in accordance with contracted profiles for industry, Australian Qualifications Framework (AQF) levels and age of New Apprentices.
- 5. Contracted minimum commencement numbers are achieved against milestone targets.

The KPIs are measured through six-monthly file monitoring visits, two surveys of employers and New Apprentices satisfaction with New Apprenticeships Centres, ongoing structured desktop analysis of the New Apprenticeships Training and Youth Information Management System (TYIMS) database, and targeted monitoring undertaken by DEST State Office staff.

Structured desktop analysis includes the production of a monthly New Apprenticeships Support Services Performance Report for DEST executives which analyses a range of data on the operation of the programme from the TYIMS database.

Targeted monitoring involves DEST State Office staff contacting a sample of employers and New Apprentices soon after they have been visited by a New Apprenticeships Centre representative to confirm service levels set by operating guidelines have been met.

The Department's Audit and Investigations Group also reviews in detail the application of the New Apprenticeships Incentives Programme and New Apprenticeships Support Services Operating Guidelines by auditing four New Apprenticeships Centres annually.

New Apprenticeships funding conditions

The National Vocational Education and Training (VET) planning arrangements under the Australian National Training Authority (ANTA) Agreement provide for a set of agreed annual national priorities to be implemented. For 2005, Australian and State/Territory Ministers have agreed as a priority to 'meet industry skill needs, responding to the evolving needs of existing industries, reducing skill shortages and meeting the needs of new and emerging industries'. State/Territory VET plans must include strategies for dealing with future skill needs and skill shortages. As part of their VET plans, States/Territories are required to provide activity tables detailing the planned numbers of New Apprenticeship commencements and New Apprentices in training for 2005. Under the ANTA Agreement, State/Territory VET plans must be approved by the ANTA Ministerial Council in order for additional Australian Government funds to be paid.

Monitoring of formal training and employment outcomes

The framework of key performance measures under the National VET Strategy 2004-2010 provides for surveys of students' employment outcomes. Data is reported annually, including for those VET students who are New Apprentices, in the Student Outcomes Survey series published by the National Centre for Vocational Education Research. Performance in this area is also reported in ANTA's Annual National Report of the Australian Vocational Education and Training System. There are no specific conditions in the ANTA Agreement, however, requiring States and Territories to monitor formal training and employment outcomes for New Apprenticeships.
