Question:

Senator Campbell asked at *Hansard* pages 46 and 47:

Could the OEA provide figures on the number of enquiries Job Watch has taken with regard to AWA's over the last 3 years under the terms of their current contract?

Answer:

JobWatch has reported to the OEA that over the last three financial years the organisation has received a total of 334 enquiries which relate to AWAs. This amounts to 0.37% of all AWAs lodged/approved over this same period in Victoria.

JobWatch has also provided data of AWA related enquiries over the last 6 years to the Senate Employment, Workplace Relations and Education Committee. In the submission, JobWatch reports that over the six financial years to 30 June 2005, JobWatch received 595 AWA related enquiries. This amounts to 0.45% of all AWAs lodged/approved over this same period in Victoria.


AWA related enquiries typically comprise a minority of enquiries to the agency, comprising approximately 2% of all enquiries to JobWatch. As can be seen in Table 1, this equates to an average of less than 60 enquiries every quarter. As AWAs become more prevalent in Victoria, the proportion of AWA related enquiries also appears to be increasing, although at 2.4% in the June 2005 quarter (the latest available data), this proportion is statistically insignificant when compared with other issues dealt with by JobWatch such as award breach enquiries and those regarding unfair dismissal.

The number of AWAs approved for Victorian employees has increased rapidly over the last two financial years, growing by 83% from 2002/03 to 2003/04 and then by more than double the following year. Figure 1 shows that the increase in AWA related enquiries received by JobWatch are proportionate to the increase in AWAs in the State.
