### **Question:**

Senator Marshall asked in writing:

Further to QON W274-06 from the previous Estimates, can the Office please update the data provided in the answer to take in to account what has occurred since the previous Estimates round.

QON W272-06 refers to data request for the following categories:

- I. For people under the ages of 21, 18 and 15;
- II. Give the monthly breakdowns of the last 6 months; and
- III. Identify them by Industry Sector.

#### **Answer:**

- a) AWAs approved in the financial year so far (July 2005 October 2005):
  - AWAs approved for persons aged greater than or equal to 18 but under the age of 21 (i.e. < 21): 5,782
  - AWAs approved for persons aged greater than or equal to 15 but under the age of 18 (i.e. < 18): 3,131
  - AWAs approved for persons under the age of 15 (i.e. < 15): 193

It should also be noted that the AWA approval figures are not cumulative i.e. < 21 years of age does not include figures already disclosed for the <18 and <15 age categories.

b) AWAs approved for persons under the ages of 21, 18 and 15 per month, for the 2005 Calendar year so far (end of October 2005).
