Question:

DEST Annual Report 2005-06 (p.95) details the number of full time students supported by the Youth Allowance and Austudy. Of the 150,230 full time tertiary students in receipt of Youth Allowance, 65,112 achieved independence through meeting the workforce participation requirements (43%). The number of students achieving the independent rate of Youth Allowance through workforce participation seems high at 43%.

- a. Is this higher than previous years? Is there a trend in this data?
- b. Can DEST provide the number of students, and as a percentage of the total recipients, who have achieved the independent rate of Youth Allowance through workforce participation for the last 5 years?
- c. Has DEST examined this issue in any greater detail? Is it explained by students working more whilst studying, meeting the workforce requirements by taking time off study, or other reasons?
- d. What is the age profile of the students who receive the independent rate? Is it higher for students in their second or third years at university (19 or 20)?

The data in this table has been prepared for a point-in-time at a date in mid-June of each year and may differ slightly from point-in-time data at other dates, such as 30 June of the same year.

- c) DEST undertakes regular monitoring of transitions and pathways of school leavers. Evidence from administrative data shows that the number of Year 12 completers going straight from school to tertiary study has declined by five per cent between 2000 and 2004. Research suggests that some of those not taking up study in the first year after leaving school will do so after a gap of one or more years. The number of Year 12 completers commencing university after a gap year has increased from around 14,900 in 1997 to 18,100 in 2004, and as a proportion of Year 12 completers has increased from 8.8% to 9.2% over the period. Changing patterns in transition to tertiary study will influence the proportion of YA recipients claiming independent status through work force participation.
- d) The following table provides data on the age profile of full-time students in receipt of Youth Allowance with independent status, as at 16 June 2006.
