## **Question:**

Senator Marshall asked in writing: How many cases has the Minister intervened in for 2005 and 2006 to date? What was the nature of the Commonwealth's intervention in each case, and what was the cost of each intervention? What was the total cost of running these interventions?

#### Answer:

The Minister has intervened in 20 cases and the Attorney-General intervened in one case, for which the Department was responsible for costs, in the period 1 January 2005 to 30 November 2006.

The nature and cost (GST exclusive) of each intervention as at 30 November 2006 was:

#### **AIRC**

The Minister intervened in the public interest in the following cases:

In the matter of an Appeal against the decision of Commissioner Gay at Melbourne on 19 August 2005 in an application by Australian Liquor Hospitality and Miscellaneous workers Union under section 113 to vary the *Australian Liquor Hospitality and Miscellaneous Workers Union Support Employment (Business Enterprises) Award 2001* C2005/4523

Decision: Discontinued 22/11/2005

Nature of case: The Government sought intervention on the grounds: (a) if the

application is successful, the outcome would directly impact on the interest of the Australian Government as a major client of the Queensland building and construction industry; and (b) public interest, including any effect of the decision on the building industry and the Queensland and Australian

economies. The Full Bench of QIRC felt that the Minister had

sufficient grounds to intervene in the matter based on the Australian Government's special interest in, and responsibility for, the national economy, of which the building construction industry is a vital part. The Bench noted that "the Minister's

involvement [in the application] will provide a unique

perspective".
