Please provide the following data on Youth Allowance (Other) recipients:

- i. Overall number of YA(O) recipients, by sex and age group (under 18, 18-20, 21 years and over) and Indigenous and disability status
- ii. Number of recipients (disaggregated as above) who are early school leavers
- iii. Distribution of Employment Pathway Plan activities of early school leavers on YA(O) (e.g. vocational training, participation in Stream 4)
- iv. The proportion of early school leavers on YA(O) that, six months after a point in time when they received this payment, transitioned to
 - a. employment and off income support
 - b. full time education or training and off YA(O)
 - c. other income support payments
 - d. other destinations

iii. Distribution of Employment Pathway Plan activities of early school leavers on Youth Allowance (other) (e.g. vocational training, participation in Stream 4)

As at end September 2010:

- around 23 per cent of Early School Leavers were in Stream 4 services with Job Services Australia providers
- approximately 19 per cent of Early School Leaver Employment Pathway Plans included full-time or part-time study at an accredited institution
- around 12 per cent of Early School Leaver Employment Pathway Plans include participation in suitable programs including the Adult Migrant English Program, Australian Apprenticeship Access Program, Community Development Employment Project – Work Readiness Service Stream, the Language, Literacy and Numeracy Program, the National Green Jobs Corps, New Enterprise Incentive Scheme training, Youth Connections or work for the dole or green corps activities
- around 34 per cent of Early School Leaver Employment Pathway Plans included descriptions of a range of different activities such as attendance at state-based programs, provider-based training, drug and alcohol counselling, relationship counselling, and obtaining driver's licence
- approximately 6 per cent of Early School Leavers were temporarily exempt from participation requirements
- approximately 3 per cent were participating in Disability Employment Services
- around 3 per cent had employment or work experience activities.

iv. The proportion of early school leavers on Youth Allowance (other) that, six months after a point in time when they received this payment, transitioned to (a) employment and off income support (b) full time education or training and off Youth Allowance (other) (c) other income support payments (d) other destinations

The requested information will be included in the evaluation, which isexpected to be completed in the second half of 2011, of the Early School Leaver changes to Youth Allowance as part of the Compact with Young Australians. Preliminary analysis of administrative data for Early School Leavers who were granted Youth Allowance (other) between 1 July 2009 and 30 September 2009 indicates that six months after being granted payment almosthalf of them were receivingYouth Allowance (other), approximately one-third had left income support and the remainder were receiving a different income support payment.

v. A breakdown of types and durations of education and training courses undertaken by early school leavers on Youth Allowance (other), including those who transferred to YA(student) and the proportion that successfully completed each type of course

The information requested is not readily available. The evaluation of the Compact with Young Australians will include analysis of Early School Leaver education and training.
