Question

Work experience phase of Job Services Australia

Please provide data on the number, characteristics, and employment outcomes of unemployed people who participated in the Work experience phase of Job Services Australia (within each Stream and overall) over the year ending March 2011, in the same format (and with the same breakdown of characteristics and outcomes) as in Table 2.1 of the latest Labour Market Assistance Outcomes publication.

Answer

The Post-Program Monitoring survey is used to measure the labour market status of job seekers who participate in department-funded employment programs and services. The employment rate for the Work Experience Phase is determined by surveying job seekers after they exit the Phase or reach 12, 24 (and so on) months participation.

Robust representative outcome estimates are dependent on there being job seekers that have reached 12 months participation in the Work Experience Phase in the reporting period. This is only the case for Streams 2 to 4, where under the Job Network to Job Services Australia transition rules, some job seekers commenced in the Work Experience Phase in 2009 or early 2010. Given the relatively small numbers of job seekers for whom outcomes can be reported, results for these streams have been combined using standard statistical techniques to allow for the estimation of the outcome rate.

Table 1 presents results for Stream 2 to 4 job seekers who participated in the Work Experience Phase in the 12 months to 31 March 2011 (with outcomes measured around three months later).
