JOINT WORKING GROUP TERMS OF REFERENCE

Joint Working Group to Progress the Collection of Nationally Consistent Data on Students with Disability

The joint working group will be chaired by DEEWR and comprise education authorities, including the Catholic and independent sectors and the Australian Curriculum, Assessment and Reporting Authority (ACARA).

The working group will be tasked to:

- Examine issues arising from the PricewaterhouseCoopers report, Trial of a Model for Collecting Nationally Consistent Data on School Students with Disability, specifically:
 - identified refinements to the model to include:
 - further relevant examples into the descriptors of each level of adjustment in the model; and
 - a 'multiple disabilities' category;
 - guidance for schools regarding criteria for the inclusion of students with disability in the model that have been 'validated' by an Education Authority;
 - consultation processes between students, parents/carers and schools about adjustment;
 - whether the four adjustment categories capture enough of the diversity of effort by schools in meeting the needs of students with disability; and
 - whether the collection methodology is appropriate for special schools.
- Propose an implementation strategy to commence the collection of nationally consistent data on school students with disability. This includes preparing a business case for AEEYSOC in April 2012 which details processes for commencing the collection of the national data set. Business case should include advice on :
 - appropriate collection methodology;
 - the timeframe for national data collection and reporting;
 - options for the presentation and reporting of nationally consistent data on students with disability on the school profile pages on My School; and
 - workforce issues associated with implementation and potential impacts on schools and school authorities.
